Every entry shall constitute an agreement that all participants (which include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler, and the horse), for themselves, their principals, representatives, employees and agents:

- 1) Shall be subjects to the constitution and the rules of the association and the local rules of the competition;
- 2) Represent that every horse, rider, driver, and handler is eligible as entered;
- 3) Agree to be bound by the constitution and rules of the USA Equestrian (formerly AHSA) and the SEHJ and will accept as final the decision of the managing committee on any question arising under said rules, and agree to hold the SEHJ, USA Equestrian, their officials, directors and employees harmless for any action taken;
- 4) I Agree that I/They participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and I/They agree to indemnify and hold the USA Equestrian, the SEHJ, the competition, and their officials, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during or after or in connection with the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of the USA Equestrian, the SEHJA or the competition.
- 5) I agree to indemnify and save harmless, the SEHJ, its show and directors, the facility and all singular, the directors, officers, members, employees and agents thereof from and against any and all loss, cost or expense of any claim thereof of whatever nature arising or to arise for and on account, or any reason of the entry or entries hereby made. And agree to allow photos of, to be used in web site and other SEHJ publications.
- 6) Entries postmarked by closing date of event, 7 days before show will qualify for pre-entry discounts If the entries are postmarked after the closing date, a \$5.00 late fee will be charged for each class added after closing date to show balance. Stall fees will bill to all entries not cancelled before the closing date. You may send a deposit in the full amount. If you do not send in the deposit bring an open check to the horse show office the day of the show to pick up your number.. If the entry form is missing any information or signatures, We will not except. We will try to contact to verify entry. If you have any questions, please contact your trainer.
